
At our AGM held on 14 January (minutes will be sent out soon) we were able to fill most of our Branch Committee seats.

# Pay dispute (continued)

The branch understands that members have very mixed feelings about the HE pay dispute. This is a national issue and it was supported (and rather narrowly at that) by a national ballot. That result does not necessarily reflect how our own members feel.

It is very important that we make clear that we will not ostracise or make life uncomfortable for members who do not wish to join in industrial action.

We ask our members who do not agree with the industrial action and who do not want to participate in it to respect the views of members who feel differently and, most importantly, please stay with UNISON.

Some members have wrestled with their consciences and decided they would rather leave UNISON than cross a picket line, for example. But there is no need to do so, all our members are valued equally and we wish to keep sight of the longer-term picture: UNISON enjoys constructive relations with the University and both parties recognise that strong trade unions with diverse memberships representing a broad cross-section of staff serve all our interests. This will remain the case long after the current dispute is resolved.

# Taking part or not... let us know your thoughts

A member writes:

"I've been attending a training course (seven or eight half-day sessions) over the last few weeks. The exam takes place on the day of proposed strike action. I'm worried that all of those sessions would be wasted if I don't show up on February 6th."
